Welcome to the opening of the Unified Communications Center (UCC). Today we realize the Mayor's expansive vision to better serve and protect District residents, businesses, visitors, and federal employees.

Mayor Williams envisioned the UCC as a premier facility to optimize public safety call-taking and dispatch. Today, the UCC

opens a new environment geared to delivering the best E9-1-1 response, supported by state-of-the-art technology, best-practice call center design, and a child development center and fitness center to help employees feel and do their best.

The Mayor saw the UCC as the place to fulfill the District's responsibility to facilitate a coordinated local, regional, and federal emergency response. Today, the UCC debuts as the Regional Incident Command and Control Center, the hub for emergency response among District, federal, and regional first responders in the National Capital Region. The UCC also houses our regional interoperable wireless communications and control infrastructure including 72-hour emergency self-sustaining capabilities, fully redundant communications systems, and attack-resistant building design.

The Mayor also envisioned the UCC as a source of new development here in Ward 8. Throughout its construction, the UCC has offered new job prospects in the community and a new magnet for neighborhood revitalization. It was designed with special attention to historic preservation of the St. Elizabeths campus.

The UCC became a reality through the collaboration, leadership, and dedication of hundreds of people. My agency and I have been proud to lead this sustained effort. We're proud of our partnership with the Local, Small, and Disadvantaged Business Enterprise (LSDBE) community and our record of exceeding our 35 percent LSDBE goal throughout the project. We're grateful to our many, many partners on the UCC.

Together, we've delivered this grand facility, a vital center for the District and the region, and a model for other jurisdictions around the nation.

#### ABOUT THE UCC

The vision for the Unified Communications Center (UCC) was born from Mayor Anthony Williams' commitment to public safety and first-class customer service.

The UCC is a 127,000-square-foot, state-of-the-art communications center and home to the Office of Unified Communications. The UCC consolidates key public safety communications functions of multiple District of Columbia agencies, including Metropolitan Police, Fire and Emergency Medical Services, and Emergency Management. The UCC will also house the Mayor's Emergency Command Center, the Mayor's Citywide Call Center for constituent service requests, the District Network Operations Center, and the Regional Incident Command and Control Center.

This government-wide initiative, designed to optimize the use of people, technology, and business processes, also provides economic development and community revitalization benefits while strengthening public safety for District citizens. In the

case of a regional emergency this advanced facility can host and coordinate regional and federal agencies and key decision-makers.

#### **CUTTING EDGE TECHNOLOGY**

The UCC is one of the nation's premier integrated call centers and public safety/emergency response facilities. The UCC will house the city's regional interoperable wireless communications and control infrastructures and serve as the metropolitan and regional interoperability hub for public safety radio and other wireless communications. The UCC utilizes cutting-edge technology designed to help the District further reduce the abandoned call rate and answer emergency calls faster, ultimately improving response times to emergency and non-emergency calls.

#### **COMMUNITY INVOLVEMENT**

The UCC is located in the District's Ward 8 and is part of the Mayor's Government Centers Initiative, which locates government facilities in

neighborhoods to bring services closer to citizens and to support community revitalization. The building serves as an anchor in community revitalization and development efforts east of the Anacostia River.

## COMMITMENT TO EMPLOYEES

The UCC is open 24 hours a day, 365 days a year. The building will house 425 staff members over a 24-hour period. Built with the employees in mind, the UCC includes an 11,000-square-foot child development center, an exercise facility complete with lockers and showers, a brightly lit cafeteria, and a terrace retreat overlooking the city.
