Dear Chairperson Allen:

I am writing in response to your inquiry into the Office of Unified Communications' (OUC) handling of an incident on March 14, 2022, regarding an individual suspected of being under the influence of a controlled substance who jumped into the Washington Channel. Below is a timeline of the incident and a summary of our findings.

Unofficial Timeline March 14, 2022 - Overdose at 4th Street & N Street, SW

18:15:10	1st 911 call received from a caller who reports seeing a male rolling around on the ground yelling and screaming at $4^{\rm th}$ and N Street, SW
18:15:46	OUC call taker selects the ODDRUGS—ALCOHOL OR STREET DRUG INTOXICATION – RESPONSIVE event type and sends the call for dispatch
18:16:05	OUC FEMS dispatcher dispatches Ambulance 18
18:16:59	Ambulance 18 is en route
18:18:32	2^{nd} 911 call received from caller reporting that the male is jumping on vehicles in front of 1245 4th Street, SW
18:19:22	3 rd 911 call received from caller reporting that the male is walking back and forth in the block between M and N Streets scaring passersby
18:20:47	OUC MPD dispatcher updates the event record to reflect that there are no available police units
18:24:52	Ambulance 18 arrives on scene
18:26:21	Ambulance 18 raises the OUC FEMS dispatcher to request police by inquiring, "can we have MPD respond?"



18:27:17	The event record is updated by the OUC FEMS dispatcher to reflect that Ambulance 18 is standing by for assistance from MPD
18:33:11	OUC FEMS dispatcher informs Ambulance 18 that police assistance was requested again per their request
18:33:18	Ambulance 18 informs the dispatcher that "the patient is belligerent, running all over the place, hurting himself. We can't contain him. Possibly has PCP onboard"
18:34:16	The event record is updated to state, "PER A18 PT IS IRATE A18 NEED ASSISTANCE WITH PT" $^{\prime\prime}$
18:36:24	OUC MPD Dispatcher voiced requests for police units
18:37:12	1 st available MPD unit goes en route to the incident
18:37:23	The event record is updated to reflect that the patient was running in and out of traffic and was removing his clothing; the event type is changed from MENTAL to LEWD; the incident location was updated to 1250 $4^{\rm th}$ Street, SW
18:38:55	Ambulance 18 requests a medic unit and requests that the dispatcher again notify MPD that assistance is needed; also informs the dispatcher the incident scene is now "off P Street on the riverside"
18:39:03	OUC FEMS dispatcher dispatches Medic 7
18:39:47	OUC FEMS dispatcher goes over the radio to inform Medic 7 of the updated incident location
18:42:28	Ambulance 18 calls a 10-33
18:43:12	1st MPD unit arrives at 1245 4th Street, SW
18:44:53	Ambulance 18 raises the OUC FEMS dispatcher to advise that the patient just jumped into the water
18:45:27	Ambulance 18 advises Battalion Chief 6 that a water rescue assignment is needed
18:46:37	Fireboat advises that 1 Harbor Boat is on scene as well as water rescue support
18:46:43	2 nd available MPD unit goes en route to the incident
18:53:51	MPD advises that the patient was located under the pier
19:02:36	MPD advises that the patient is out of the water
19:19:36	The patient is transported to Washington Hospital Center

Summary

OUC received multiple 911 calls regarding this incident. Given the information provided by 911 callers, it was properly classified as a Priority 2. Further, in less than 1 minute of receiving the first 911 call, OUC personnel dispatched a FEMS unit and attempted to identify an available MPD unit to send as well.

Once the FEMS unit arrived on the scene and established command, OUC personnel maintained contact with the FEMS unit and continually updated the CAD event record with the information they provided, while the patient moved around in the vicinity of the original incident location. OUC personnel also continued efforts to identify available MPD units to assist as the incident developed. Consequently, police were enroute before the FEMS unit made the 10-33 distress call and arrived nearby less than 1 minute later.

MPD Harbor Patrol was also on the scene and located the patient under the pier within approximately 1 minute of the FEMS unit advising that the patient had jumped into the water and requesting water rescue support.

Findings

This call was properly classified and there was no delay in service provided by the Office of Unified Communications.

During the preliminary review of the incident, OUC, FEMS, and MPD agreed that on future FEMS calls when police assistance is requested, that an MPD official should be notified via the radio when police units are not available, regardless of event priority level. OUC is actively working to schedule a hotwash of this incident with FEMS and MPD to document this new practice and to examine the overall response more deeply.
